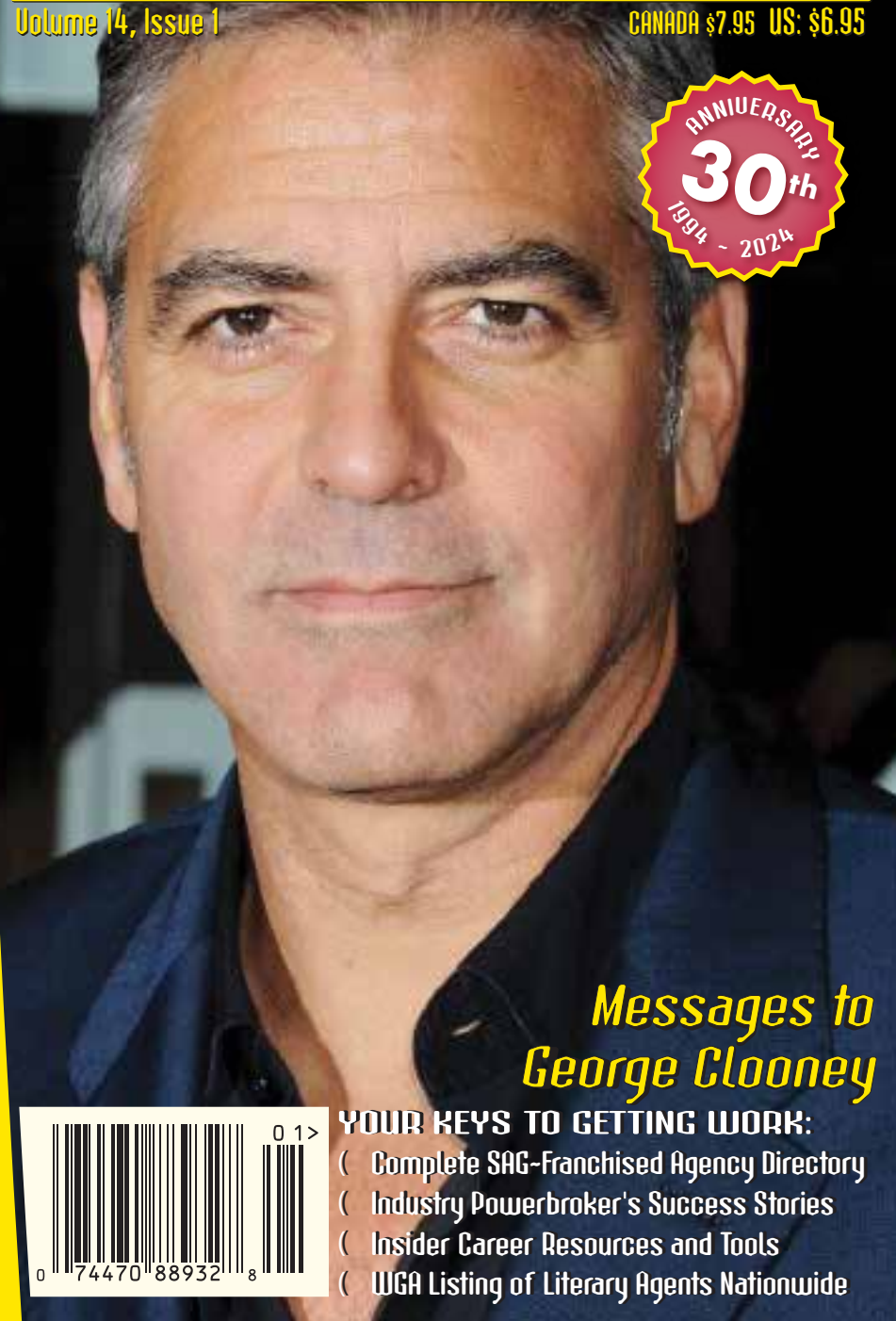

It takes stalwart individuals (right Me Too Movement, etc.) coming forward to "Right the Wrongs," and amend the laws, so that EVERY talented individual can claim their rightful destiny—expressing their heart's passion and creativity in the Motion Picture and Television Industry. We crave just the "Right" attorney—a "Ceaseless Warrior"—who shares our Determination, Drive, Hard Work, and Grit Ethics.



Enter Bradley Gage, Esq., founding partner of Goldberg & Gage (now Brad Gage Law, APC), whose passion for what he does is only surpassed by the precision with which he does it. With a resume that reads like a Hollywood A Lister— a client list that proudly encompasses numerous prominent individuals (judges, politicians, city managers and police chiefs), his victories have been many. Three Times named to Top 100 U.S. Attorneys, Six times nominated as Trial Lawyer of the Year, Twice nominated Street Fighter of the Year, prominently featured in Who's Who in North America (2019-2020), while being nominated for Top U.S. Lawyer in Sexual Orientation Discrimination (Elite Lawyers Organization), and notably appearing on the National Trial Lawyers Top 100 Trial Lawyers roster (2014, 2016, 2018 2019, 2023), Bradley Gage, Esq. is definitely a SUPER LAWYER (2005-2024)!

"I knew from a very young age that the field of law was for me," shares the ever charismatic Gage. In the late 50's and early 60's, the legal field was limited for many talented attorneys (Jewish, Black, etc.). My father (being Jewish), was able to secure a position at the City Attorney's Office. It was there that he joined forces with Johnnie Cochran, Esq.—a trail blazer in Civil Rights (at that time there were only 72 African American Trial Attorneys in Los Angeles). I experienced, first hand, the Justice that an effective attorney could achieve through the law. They showed me that lawyers protect those who are most vulnerable and in need of protection. I have made this my unrelenting quest.

I only take on cases with just causes. Unfortunately, in society, we are still witnessing minorities (especially Black Americans and Latin Americans) not being treated equally. In two years time, in Beverly Hills, we saw over 1088 people of color arrested, with only TWO convicted. Secret emails that we recovered revealed toxic opinions that 'their presence made the city look like a ghetto'—they were referred to as Thugs, Pieces of Sh...t, Douche Bags. Etc. A Rodeo Drive Task Force was formed to remedy the situation. Over 90% of the people the task force arrested were Black, but the city of Beverly Hills is only 1.9% Black. We have brought forth a Class Action Suit seeking justice for the 1086 Black Americans arrested but not convicted.

We have also found that racial profiling can be prominent in our own police forces. Most recently, in Pasadena (where the Police Chief is actually African American), officer Taisyn Crutchfield (an African American Woman) was allegedly subjected to racial discrimination and retaliated against when she tried to step in to deescalate a situation in which another officer and suspect were involved. It has been discovered that suspects were enticed into (paid) to start fights with unsuspecting officers that were just trying to do their jobs. In a city which touts the iconic Rose Parade—we have found that these Roses indeed have Thorns.

In the Riverside police department, cases of racial discrimination with Latino and female officers are now being filed. There is MUCH to be DONE—and I am all about doing it!

I am a big supporter of the LGBTQ community. Gay couples who want to have a family (and certainly deserve it) can fall victim to an inappropriately chosen surrogacy agency. We have gone after these exploiters.

I am a respector of the Me Too Movement—and all movements of awareness that reveal injustice. Again, every Talented Individual with Determination, Drive, Grit and a Hard Work ethic deserves a Seat at the Motion Picture and Television Table. I will be there for them."

When asked what was his "SECRET OF SUCCES", Bradley Gage, Esq. simply stated, "A critically supportive team of attorneys and dedicated staff who work with me in a collaborative effort, and an Amazingly Supportive wife, kids, parents and family. I like to think that every case that we win makes it better for everybody."
